Official Rules

No purchase is necessary.

- 1. ELIGIBILITY** – Participation in the “\$90 for You \$90 for Good Giveaways” is limited to eligible persons who are 18 years old or older and United States Citizens. By submitting an entry, you agree to be bound by these Official Rules. The Campaign period begins on November 24th, 2025, at 12:00 a.m. EST, and ends on December 31st, 2025, at 11:59 p.m. EST, and applies to entries received by Arbor Financial Credit Union (“the Credit Union”) during this period. All winners will be notified by the Credit Union. If any prize is unclaimed, an alternate winner may or may not be chosen. Employees, officers, directors of the Credit Union, and immediate family members (spouse, parents, siblings, children, and their spouses), and persons living in the same households of each of the above are ineligible.
- 2. PRIZES** – The Credit Union will award a total of five (5) \$90 cash or gift cards, in the Credit Union's sole discretion, equal to \$90 in value that will be presented to winners at a branch for pick up. Each user is only eligible to receive one award during the promotion.
- 3. HOW TO ENTER** – A new Giveaway post will be added to our social media channels each Monday during the campaign period. To enter, users must like, comment, and share the post before the following Sunday. For example, the first giveaway will be posted on Monday, November 24, 2025. Users will need to like, comment, and share that post by Sunday, November 30. Then, on December 1, another chance to win will be posted.

A submission can also be entered by mailing a 3 x 5 postcard with your name, address, and telephone number to Arbor Financial Credit Union, Attn: \$90 for you \$90 for good Giveaway, 1551 South 9th Street, Kalamazoo, MI 49009. One entry per person, per submission, no photocopied or mechanically reproduced entries accepted, and the Credit Union is not responsible for lost, late, misdelivered, incomplete, or postage-due entries. Mailed submissions do not add additional entries. Entries must be received by December 31, 2025, at 12:00 p.m.

- 4. WINNER SELECTIONS** – One winner will be selected every Monday, each week after the giveaway announcements.

Selected winners will be notified by direct message on Facebook or Instagram, by telephone, or by email following the drawing day. In the event a selected winner is unreachable within three days or cannot accept the prize for any reason, the selected winner will forfeit the prize, and an alternate winner may or may not be

selected from the remaining eligible entries. No transfer or substitution of a prize is permitted by the winner. No cash or other considerations will be paid. The odds of winning will depend upon the number of eligible entries received.

- 5. CONDITIONS OF PARTICIPATION** – The Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Campaign and acceptance of a prize. Entrants agree to be bound by the terms of these Official Rules and by the decisions of the Credit Union, which are final and binding on all matters pertaining to this campaign. By accepting a prize, the winner agrees to hold the Credit Union and its employees harmless for any injury or damage caused or claimed to be caused by participation in the Campaign or acceptance, receipt, possession, or misuse of the prize. The Credit Union is not responsible for any printing, typographical, mechanical, or other error in the administration of the Campaign or in the announcement of the prize.
- 6. PUBLICITY AUTHORIZATION** – The Credit Union may use the winner's name, likeness, and city name for promotional purposes without additional compensation.

The Campaign winners recognize that the Winners List is public information that will include their name and is presentable upon request to the Credit Union.
